Unity Center for Behavioral Health

As the first behavioral health center of its kind in the region, the **Unity Center for Behavioral Health** is poised to become a national model for providing more immediate, compassionate mental health care in times of crisis. The goal for this unprecedented collaboration between Adventist Health, Kaiser Permanente, Legacy Health and Oregon Health & Science University is to provide care for all those patients in need through a combination of emergency, inpatient and outpatient services. All organizational partners have embraced the concepts of hope, recovery and resilience to guide this new venture.

The right care at the right time

It has been documented by experts serving individuals and families affected by mental health issues that the mental health system is broken. In our current environment, behavioral health patients are often placed in emergency department exam rooms for hours or days as they wait for a more appropriate care setting to be available.

We can and will do better. The Unity Center will provide coordinated psychiatric services for patients who need more immediate psychiatric care, or are trying to transition back to their home or community.



Highlights of the Unity Center

- 79 adult patient beds and 22 beds for adolescents
- Continuing care will be coordinated with local care organizations housed in the building
- Community-based support groups will help transition patients upon discharge
- Thoughtful design that will contribute to the healing process
- Projected to open in November 2016, the Unity Center will be located on Legacy Health's Holladay Park campus following renovations
