Activities and Outside Space

Introduction

"Meaningful activities are recognized as a critical component of good quality dementia care (NICE 2008, NAPA/COT 2008). Getting outside and being outside are central to health and well-being, and it is important therefore to include the opportunity to do activities – to engage the person, to add pleasure and quality to the day by encouraging people to go outside and to stay out.

Activity is a critical means by which we as human beings express ourselves and interact with the world around us and as such, activities are essential to human existence, health and well-being.' (COT/ NAPA 2007). Lack of activity and lack of pleasure in activity are associated with higher rates of mortality or depression, reduction in social functioning, physical well-being, increased isolation and loss of quality of life (Mozley et al 2004, Mor et al 1995, Alessi et al 1999 as cited by Alz. Society 2007)."
