Instructions: Read the following before going to the drug testing site

- 1) Drug testing **must be completed within 48 hours** of job offer.
- 2) Select any drug testing site listed on the reverse side of this form.
- 3) No appointment necessary, walk-in service. Hours & expected wait times vary.
- 4) **Bring this form and Photo ID to the collection site.**
 - Avoid drinking excessive liquids the day prior to collection
 - Drink less than 12 ounces the 3 hours before collection
 - Collection times vary. You must plan to stay until screening is completed.
 - Guests, children, pets are not allowed at the drug testing site.
 - Results may take up to a week for processing and will be forwarded to Recruiter
- 5) Prescriptions will be verified by a 3rd party medical group named "Paragon MRO".
 - Applicants must respond to queries in a timely manner or may forfeit job offer.
 - Do not discuss your prescription with the Recruiter or Hiring Manager.
- 6) You may be contacted for another sample if the first was not sufficient for testing.
