All Legacy hospitals recognized as leaders in LGBTQ care



The Human Rights Campaign Foundation has designated all of Legacy's hospitals as "leaders" in lesbian, gay, bisexual, transgender, and queer (LGBTQ) health care equality.

The findings were part of HRC's Healthcare Equality Index 2018, an annual survey that gives health care facilities the information and resources they need to ensure that LGBTQ people have access to truly patient-centered care.

Legacy's hospitals dominated the designations for our service area. Aside from Legacyfacilities, only four other Oregon hospitals — and no other hospitals in Southwest Washington — received a score of 100 and achieved the designation as a "Leader in LGBTQ Healthcare Equality."

The Human Rights Campaign Foundation is the educational arm of the country's largest LGBTQ civil rights organization. Their index evaluates hospitals on four criteria:



- Non-discrimination and staff training including non-discrimination of patients, an equal visitation policy, employment nondiscrimination and staff training in LGBTQ patient-centered care.
- 2. Patient services and support including services and support for LGBTQ patients, collecting patient self-identification information, and informing patients of their rights to designate a medical decision maker.
- Employee benefits and policies including equal benefit, and benefits and policies impacting transgender employees.
- 4. Patient and community engagement focusing on outreach and promotion to the LGBTQ community.

This was the first year for all of Legacy's care facilities to achieve the Leader designation. Unity Center had just opened during survey period for the 2017 listing, while Legacy Silverton Medical Center was accredited as a "Top Performer" due only to the timing of executive briefing training.

CMS ends rule on medical students' notes in EHR

The Centers for Medicare and Medicaid Services has ended a 2008 policyrequiring teaching physicians to redo any patient medical record notes written by medical school students.

Background

CMS had previously barred providers from using student notes in patient medical records. Teaching physicians had to rewrite every note their students entered into patients' records.

CMS' new policy

The revised guideline, with an implementation date of March 5, 2018, no longer requires teaching physicians to redo notes written by medical students. Instead, physicians need to review and verify that the information entered by medical students is accurate.

Impact to Legacy physicians

This is good news for physicians who precept medical students and those who have been considering the opportunity. The documentation burden maybe eased by the medical student's ability to document the visit. Nonetheless, close supervision of the student is still required, including editing and reviewing the notes to ensure that the history, physical, results transcription and medical decision-making are accurate.

Attending physician documentation of involvement in the patient's care is required with a statement in the medical record, such as, "I was present with the medical student during the history and exam. I discussed the case with the student and agree with the findings and plan as documented in the student's note." The attending is responsible for the accuracy of the record should a chart or case review occur.
