To provide our patients with the best surgical outcomes, 90% of surgeries performed at our hospital use robot-assisted technology. However, using this technology can cause surgery delays if a patient needs to be moved during a procedure. **With your help, we can change this and make sure our surgeries stay safe, on schedule, and as precise as possible.**

Patients can have the fastest and safest robot-assisted surgeries possible when their operating room is also equipped with a specialized adjustable table. The table and surgical robot are connected by software that allows them to move quickly and precisely in coordination with each other. This reduces the need for additional time under anesthesia which can add to a patient's risk during surgery.

This innovative equipment also allows the surgeon and team to react without delay to any unforeseen situations that may arise once surgery is underway. Repositioning a patient can be especially helpful if a patient is experiencing position-related distress – moving them immediately relieves such issues.
